Re: Bella Coola Aggregate Project

Although change is something many people fear, at times it has to be faced, and this is one of those times for our community.

The attached document drawn-up in support of the above project and circulated through the local businesses resulted in 244 signatures from valley residents who are concerned about the economy and future of our community

Currently, job employment and opportunities in the non-government sector is so low, many valley residents have been forced to either leave their families behind or move them to seek employment in other communities, even as far as Alberta.

Why are they leaving? As Assistant Manager of the local Credit Union, some of the reasons known to me are:

- Four were facing foreclosure on delinquent mortgages by outside banks. They needed work to bring their loans to a current status and protect their credit ratings;
- Others had been living off their credit cards for the past year, utilizing all their credit and their cards to the absolute maximum. Without work they were not eligible for debt consolidation loans and had the choice of going bankrupt or seeking employment outside the valley to protect their credit ratings. Many have gone

to camps in Prince George, Fort St. Johns, and Alberta.

- Others would like to purchase a home. Without full-time work they are not eligible for mortgages. Therefore they are moving to where there is work and a future for their young families.
- Others tried to start new businesses. They borrowed or mortgaged their homes to receive funds for their new projects via private lending or through organizations like Community Futures. Only to discover that there are not sufficient tourists passing through the valley to support everyone, or the market for their product is extremely limited in the valley and soon saturated to the point where sales drop to nearly nil. To make these loan payments and protect their home equity and credit ratings, these people had to seek employment outside of the valley.

Whether doing mortgages or other loans on or off reserve, a primary lending criteria for all financial institutions is a minimum of one year full-time continuous employment, or three successful years of operating their own business. The proposed Bella Coola Aggregate project by No-Cents Holdings Limited and Arthon Construction Ltd. promises the security of full-time positions in an industry that would have the least amount of impact on the environment, and provide our community with a future for at least the next 20 years. Job security is very important for a healthy & happy community.

The support document is still being circulated in the community and the new signatures will be forwarded to you in the next two weeks.


